I invite your attention to the subject and references cited.

In the ref.1st cited, it was informed that Govt. vide Memo. No. 1370436/RD-I/A2/2021-1 & 2 of PR & RD(RD.I) Dept., dt:26.03.2021 has enhanced Pension SLA from 10 days to 21 days and requested to issue Aadhar seeded Digital certificates to Dappu Artists and Traditional Cobblers by providing service in GSWS Portal. It was also informed that logins are provided to all the Dy.Directors of Social Welfare in the Satte for verification of cerificates furnished by the applicants before sanction of Pension to Dappuu Artists and Traditional Cobblers. The Digital Cetificaes are validataed through Application Programme Interface (API).

In this regard, it is inform that, vide ref.2nd cited, the State General Secretary, Andhra Pradesh Dappu Kalakarula Sangham (APDKS) has submitted a representation to the Director of Social Welfare, A.P., stating that to register online

application for pensions to Dappu Artists, the Ward Secretariat officials are insisting for a Digital Certificate issued by the Social Welfare Department, due to which Dappu Artists are unable to apply for pension and requested to allow Self Declaration by the applicant till Digital Certificate is issued by Social Welfare Department.
