Sub: BCWD -APSEBCWDC - Implementation of EBC Nestham - Identification of fresh eligible beneficiaries. Communicating the guidelines and timelines to all the District Collectors and Executive Directors, DBCSCS Ltd., in the state-Revised Time Schedule - issued - Reg.

In order to provide economic up-liftment to the EBC Communities who are living below poverty line, the Government of Andhra Pradesh have issued orders vide G.O.Ms.No.02, BC Welfare(C) Department, Dated.20.04.2021 for sanctioning financial Assistance to EBC communities. The financial assistance would be Rs.15,000/- per annum for a period of 3 years amounting to Rs.45,000/- to financially empower the women of the proposed communities, aged above 45 years and below 60 years for enhancing their livelihood opportunities and live standards, on the line of YSR Cheyutha and Kapu Nestham. The orders were also issued for Operational Guidelines for EBC Nestham, Eligibility Criteria for Beneficiaries, Beneficiary Identification etc.

2. The Managing Director, **A.P. State Economically Backward Classes Welfare & Development Corporation** (APSEBCWDC) has submitted the guidelines and revised timelines to issue to all the District Collectors and Executive Directors, DBCSCS Ltd., in the state for identification of Identification of the eligibility of existing beneficiaries and identification of new beneficiaries under EBC Nestham scheme for the year 2021-22.

3. Government after careful examination of the proposal of MD, APSEBCWDC Ltd., vide reference 2nd cited, and in partial modification to the orders issued in the reference 1st cited, hereby approved the time Schedule for Identification of the eligibility of existing beneficiaries and identification of new beneficiaries under EBC Nestham scheme for the year 2021-22. The time Schedule is annexed to this Memo.

4. The MD, APSEBCWDC Ltd., Vijayawada / All the District Collectors /All the Executive Directors, DBCSCS Ltd are therefore requested to take necessary action accordingly.

Time Schedule for EBC Nestham scheme for Identification of the eligibility of existing beneficiaries and identification of new beneficiaries

Step: 1. Training on SOP (Standard Operational Procedure) by Managing Director, APEBC Corporation on data collection of women beneficiaries who are aged above 45 years and below 60 years. From the existing data base deletion of the deceased and who crossed 60 years age, and submission of the list to the Executive Directors, MPDOs and Municipal Commissioners for identification process through Mobile App / Web application.

Time-Line: 1-10-2021 to 7-10-2021

Step: 2. Door to door Survey through mobile Application by the Village/Ward Volunteers for data collection of women beneficiaries. Village/Ward Volunteer will upload the data in the web link of the Welfare Assistant as per logins provided by the APCFSS. Data collection of the beneficiaries following eligibility criteria like caste, income, Aadhar, Property etc. parameters.

Timeline: 8-10- 2021 to 10-10-2021

Step: 3.Conduct of Social Audit, as per the approved list furnished by the MPDO's/Municipal Commissioner's concerned.

Timeline: 11-10-2021 to 13-10-2021

Step: 4. Deletion of the ineligible names if any by the Village/Ward Welfare Assistants as per the reports submitted by the Social Audit teams and display the final list of beneficiaries at Village/Ward Secretariats.

Timeline: 14-10-2021 to 16-10-2021

Step: 5.Submission of the final list of beneficiaries after publication from the Village/Ward Secretariats to the Executive Directors, DBCSCS Ltd.

Timeline: 17-10-2021 &18-10-2021

Step: 6.Obtaining the approval of the eligible list of beneficiaries from the District Collectors concerned and submit the same to the Director, GSWS through online in EBC Nestham portal.

Timeline: 19-10-2021 &21-10-2021

Step: 7.Transfer of the financial assistance through Direct Benefit Transfer (DBT) as per schedule (date) to be finalized by the Government.
