The following are clarifications issued regarding re-verification of tentative ineligible cases in village/ward secretariats and for confirmation of objections raised by students at the level of MPDOs/Municipal Commissioners.

**I. Government Employees/ Retired Pensioners:**

*Even if the sibling of the student is a government employee, such a student is ineligible, as the sibling is also a member of the family.*

*If the deletion of government employee from the old rice card of the student happened prior to the academic year for which the JVD application is made, then only it may be considered as valid. If separation is made during the academic year or later to the academic year for which application is made, then it cannot be recommended as eligible, since there are complaints of artificial separation of family only to get benefit of JVD schemes.*

All applications in whose families there is a regular government employee or service pensioner are ineligible, irrespective of the salary/pension, as per G.O Ms.No.115 SWD Dt.30.11.2019.

But, in case of non-regular employees like Home Guards, if their annual income as per the last 12 months salary statement signed by their DDO is less than Rs.2.50 lakhs, then they can be recommended as eligible. The signed statement from the Drawing and Disbursing Officer shall be uploaded as proof.

**II.Four-wheeler owners:**

*If the name and aadhar number of the four wheeler owner matched, with the family member of the JVD applicant, then it shall be treated as ineligible.*

*The fact that they possessed the vehicle in the past is proof of their family income status being above Rs.2.50 lakhs p.a, even though they sold it away.*

*In case the aadhar number and name shown in six point validation does not belong to any family member of JVD applicant, then it may be treated as eligible, as it is clearly wrong seeding of someone else's adhar in the data base by Transport Department. In this case, the data base of Transport department shall be rectified.*

*If the sale of the vehicle is two years prior to the academic year for which the JVD application was filed, then only it may be considered as eligible. This is meant to prevent misuse of the scheme by transferring the ownership to some other family only to get the JVD benefit. The transfer of ownership shall be produced in the form of copy of RC of the vehicle or any such proof, attested by the Transport Department.*

*Eligibility will be cross checked with the updated data base of the Transport department, and not based on recommendation made in the portal by the secretariat. The signed document issued by the Transport Department shall be uploaded as proof.*

**III. Income Tax payee:** All students in whose families Income Tax was paid previously, they are ineligible as per G.O Ms.No.115. They cannot be recommended as eligible. The online verification already done is final and conclusive.

**IV. Land holdings in excess of the prescribed limits:**


*The member holding the land and the extent of land holdings is displayed. If student has grievance against this, a letter from Tahsildar that they do not own the land displayed in the report shall may be insisted as proof to make the student eligible. The web land data base shall also be updated. Eligibility will be cross checked with the updated data base of the Revenue department, and not based on recommendation made in the portal by the secretariat.*

*Though WEAs or WEDPSs re-verify the applications shown as ineligible, the final confirmation on recommendation to make them eligible is given to MPDOs and Municipal Commissioners only.*

MPDOs and Municipal Commissioners are requested to dispose the cases as per schedule prescribed without keeping them pending in their login. The Joint Collectors, Village & Ward Secretariats and Development are requested to monitor their disposal on daily basis as per the schedule given.
