Accordingly, that the Government recruited and posted 1.34 lakh employees in all Village /Ward Secretariats in Phase-I & II and they are working from October 2019 onwards and their probation period shall be declared by the competent authority. It is necessary and compulsory to open service Register to each employee who joined in Government service. Some Line Departments has issued instructions to open Service Registers to their Functionaries who are working in Village /Ward Secretariats and some Line Departments are yet to be given instructions to the competent authorities.
