ORDER:

In the circumstances reported by the Director of Social Welfare, Andhra Pradesh, Tadepalli in the reference 2nd read above and after careful examination of the matter, Government have decided to reduce the period from 60 days to 30 days for applying the YSR Kalyanamastu/shadi Tohfa scheme after marriage. Accordingly, the Govt. hereby make the following amendment to the orders issued in G.O.Ms.No.50, Social Welfare (EDN) Department, dated: 30.09.2022:

AMENDMENT

In the said orders –

(i) in Para 6, in Step 1 under heading "**Physical application through VSWS" & Direct online** for expression "60 days" wherever it occurs , the expression "**30 days**" shall be substituted

(ii) in **Flow Chart of Application**, for the expression "60 days", the expression "**30 days**" shall be substituted.

2. The Social Welfare/Tribal Welfare/Backward Classes Welfare/Minorities Welfare/ Women, Children, Disabled & Senior Citizens/ Labour Employment Training & Factories/ Municipal Administration & Urban Development/ GVWV & VSWS / Panchayat Raj & Rural Development Departments shall take necessary action accordingly.
